Comprehensive Needs Assessment

The district disaggregated and analyzed individual student performance based on the raw data from the STAAR Test, TPRI, and District Assessments for students in regular education and special programs. In addition, the district focused on attendance. Other areas of need were identified from staff, parent, and community input and included school climate, parental/community involvement and facilities.

Input from regular education and special programs focused on the following areas: curriculum, instruction, staffing, staff development, school organization and budgeting. Through our site-based decision-making committee, goals and objectives were established to meet identified needs.

Comprehensive Needs Assessment Summary

Major Findings:

- Improvement needed in communication between school and parents about student progress.
- Weak writing composition scores, with the average student receiving half of the maximum total points for each composition.
- Improvement needed in social studies and science.
- Train and re-certify appropriate individuals for Crisis Prevention Intervention (CPI).
- Increase the stability and aesthetics of the school facility.
- RtI program needs strengthening – Better documentation of progress of students
- Training and tools for integration of technology in classroom
- More frequent benchmarking.
- Teachers need guidance in implementing the TEKS Resource System curriculum

- Did not perform satisfactorily on a state assessment instrument, and has not in the previous or current school year performed on that instrument or another appropriate instrument at a level equal to at least 110 percent of the level of satisfactory performance on that instrument
- Is pregnant or is a parent
- Has been placed in an AEP during the preceding or current school year
- Has been expelled during the preceding or current school year
- Is currently on parole, probation, deferred prosecution, or other conditional release
- Was previously reported through PEIMS to have dropped out of school
- Is a student of limited English proficiency
- Is in the custody or care of DPRS or has, during the current school year, been referred to DPRS
- Is homeless
- Resided in the preceding school year or resides in the current school year in a residential placement facility in the district, including a detention facility, substance abuse treatment facility, emergency shelter, psychiatric hospital, halfway house, or foster group home.
